PROCEDURE FOR CARNIVAL/FESTIVAL LICENSE
FOR CARNIVALS OR EVENTS WITH AMUSEMENT RIDES**

These documents must be submitted to the Sterling Heights City Clerk's Office, 40555 Utica Road, Sterling Heights, Michigan, (586) 446-2420, at least three weeks before the carnival/festival is scheduled to begin:

1. Temporary Use Approval from the Planning Department.
2. Completed Sterling Heights Carnival/Festival license application form (attached).
3. Either Certificate of Insurance (not less than \$1,000,000) or Bond (not less than \$1,000,000) **listing the City of Sterling Heights as an Additional Insured.** (follow instructions on Temporary Use form from Planning)
4. Hold Harmless Form (this form is included in the application packet)
5. If liquor, beer or wine is being sold, proof of approval of State Liquor Control Commission (this may be faxed to the City Clerk's office when received from the State) Liquor liability insurance (not less than \$100,000) **listing the City of Sterling Heights as an Additional Insured.**
6. Copy of applicant's driver's license.
7. Listing of amusement rides including their State inspection numbers.
8. Completed application for Special Event Inspection by Fire Department (this form is included in the application packet)
9. Copy of Sterling Heights Building Department permit for tents, electrical, etc.
10. **Fees (Effective July 1, 2019):**
